Motion by Dan Glotzbach to pay bills as presented totaling \$85,670.84 was seconded by Todd Reeves and carried.

Motion by Trish Heim to approve agenda with addition of Myron Leinwetter and removal of Gregory Fankhauser and David Hickman was seconded by Rick Towers and carried.

Myron Leinwetter was present to update the council on the Kansas safe routes to school grant and meeting scheduled for April 17<sup>th</sup>, 2024 6-8pm at the Rossville Community Library.

Mayor reported on meeting with David Hickman regarding employee health insurance quote. No action was taken.

Mayor reported that police secretary Tina Dick is resigning.

Mayor reported that property at 416 Navarre had been sold and new owner plans to make repairs to property.

Utility Superintendent Alan Zlatnik reported that utility employee Chance Stum has completed and passed exam to be certified as a class CW2 water supply system operator.

Superintendent Zlatnik reported on clean up at sand/gravel storage lot and that they were doing lots of mowing.

Superintendent Zlatnik noted that he had not yet received bids for street repairs and that new section of fence has been put in at lagoons.

Police Chief Thomas Sipp provided additional information on property issues at 416 Navarre and noted that the resident is no longer at property.

Chief Sipp reported that Midwest Radar had recertified radar units and that he is checking on build dates for police vehicles.

Chief Sipp inquired about hiring someone to fill police secretary position. Council discussed advertising position or consideration of applicant. Council requested that Chief Sipp have applicant look at job requirements and will consider at next meeting.

Chief Sipp noted that he had worked the after prom and 5<sup>th</sup> and 6<sup>th</sup> grade track meet as well as reading buddies at the grade school.

Chief Sipp presented March incident report showing 54 total incidents in March with the highest speed cited in Rossville as 51mph in a 30mph zone and lowest speed cited as 31mph in a 20mph school zone.

Clerk presented application from Xochil Oyervides for drinking establishment license at 601 W Hwy 24 Trafficway. Clerk noted that fee has been paid however state license is pending approval. Following discussion motion by Todd Reeves to approve City drinking establishment license for Xochil Oyervides doing business as Jalapenos Mexican Grill upon approval of state license was seconded by Rick Towers and carried.

Motion by Trish Heim to adjourn was seconded by Todd Reeves and carried. Meeting adjourned at 6:41pm.
