The Rossville City Council meeting was called to order on Monday, August 5, 2024 at 5:58 pm by Mayor James Meyer.

Council members present were Trish Heim, Vern Sumner, Rick Towers, Dan Glotzbach and Todd Reeves.

Also present was Douglas Schreiner, Myron Leinwetter, Alan Zlatnik and Susan Duffy.

Motion by Trish Heim to approve minutes of the July 15, 2024 meeting as corrected was seconded by Todd Reeves and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$63,557.32 was seconded by Rick Towers and carried.

Motion by Todd Reeves to approve the agenda with the addition of Susan Duffy was seconded by Dan Glotzbach and carried.

Myron Leinwetter was present to answer questions regarding the City of Rossville Safe Routes to School Plan and request approval from council. Leinwetter noted that the next step would be to seek funding for the project. Following discussion motion by Trish Heim to approve Safe Routes to School Plan was seconded by Todd Reeves and carried.

Susan Duffy was present to introduce herself as candidate for Shawnee County Treasurer.

Utility Superintendent Alan Zlatnik reported that all went well for hog ball softball tournament and that the utility department is getting ready for tall corn festival. Zlatnik also reported that there were some maintenance items at the playground that would be addressed after tall corn festival. Zlatnik also reported that they would be spraying for mosquitos this week and that park has been sprayed.

Assistant Police Chief Douglas Schreiner reported that the police department had contacted owner of property at 529 Spruce regarding tree branches; contacted owner of 111 Pottawatomie regarding weeds; had conversation with city attorney regarding trees along cross creek; addressed trees overhanging roadway at 644 Pine; submitted updated forms for KDOT innovative technology program and bids for crosswalk; scheduled new Tahoe for upfit the end of August. In addition, Assistance Chief Schreiner reported that Chief Sipp would like council to consider a proposal for shift differential program for part-time officers and noted that Brooklyn's training is coming along with plans to schedule some training with Shawnee County Sheriff's records department.

Assistant Chief Schreiner reported that he had put together and provided copy of Tall Corn Festival pre-plan to RCDC, Alan and partner agencies.

Mayor reminded council that he would deliver the corn needing to be cooked for the corn eating contest and noted that Rossville Fresh Market would be donating the corn for the event.

Jim Clancy arrived at 6:58pm.

Rick Towers presented bid for repairs to ball diamond grandstand. Council had discussion regarding cost to repair compared to cost to demo and put in aluminum bleachers. Following discussion council requested that Rick Towers and Assistant City Clerk Taylor Morelli get together and put article on the City Facebook page to get opinions of the community and look at having a public meeting to discuss options.

Ordinance AMENDING SECTION 3-103 OF THE CITY CODE DEALING WITH CEREAL MALT BEVERAGE APPLICATIONS FOR RETAIL SALES IN THE CITY OF ROSSVILLE KANSAS was presented. Motion by Dan Glotzbach to adopt ordinance was seconded by Rick Towers and carried. Ordinance was assigned number 855.

Clerk presented estimates of increases to city water rates for council to review. Following discussion council requested that Clerk prepare ordinance to increase water rates over the next three years.

Jim Clancy was present to request information on splitting of lot in the Rossville Industrial Park area. Council informed Clancy that lots would need to comply with the minimum lot requirements per the zoning regulations that are viewable on the City website and that any other questions may be directed to Code Enforcement Administrator Jeffrey Overmyer.

Motion by Dan Glotzbach to adjourn was seconded by Trish Heim and carried. Meeting adjourned at 7:18pm.
