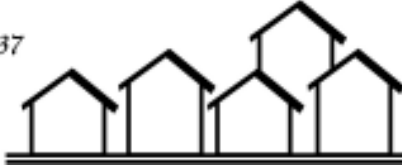

December 2, 2024

The Rossville City Council meeting was called to order on Monday, December 2, 2024 at 6:00 pm by Mayor James Meyer.

Council members present were Trish Heim, Todd Reeves, Rick Towers and Vernon Sumner.

Also present were Thomas Sipp, Alan Zlatnik and Myron Leinwetter.

Motion by Todd Reeves to approve minutes of the November 18, 2024 meeting as corrected was seconded by Trish Heim and carried.

Motion by Trish Heim to pay bills as presented totaling \$41,803.09 was seconded by Todd Reeves and carried.

Motion by Trish Heim to approve the agenda as presented was seconded by Todd Reeves and carried.

Dan Glotzbach arrived at 6:02pm.

CMB license application from Casey's General Store for sale of cereal malt beverages in original and unopened containers was presented. Clerk reported that background checks have been completed and fee paid. Motion by Dan Glotzbach to approved license was seconded by Rick Towers and carried.

CMB license application from Dawg House for consumption of cereal malt beverages on premises was presented. Clerk reported that background checks have been completed and fee paid. Motion by Vernon Sumner to approved license was seconded by Rick Towers and carried.

Clerk reported that the City of Rossville revised website had gone live.

Council inquired about updates on grant application and plans for baseball grandstand repairs. Mayor to check on update from engineer and noted that grant awards should be announced this month.

Utility Superintendent Alan Zlatnik presented bid from Schwant Tractor & Service, Inc for mower. Superintendent Zlatnik recommended purchasing X-Mark mower over Ferris as they were getting better trade in and price. Following review motion by Todd Reeves to purchase mower, bagger and strip kit at a cost of \$16,408.00 was seconded by Dan Glotzbach and carried.

Police Chief Thomas Sipp reported that he had spoken to property owners in the 500 block of Pearl Street and they would prefer that the no parking zone be established on the east side of the street. Chief Sipp also reported on: contract with KDOT for new crosswalk signals on Highway 24; officers qualifying at range; Axon cameras to be install in cars and training scheduled; Brooklyn and himself will be attending training; follow-ups on abatement notices; VIN reader has been received and will be used to verify that all the VINs are the same; mayor and council members attended court and his plans to attend Willard City council meeting to discuss law enforcement services contract.

KDOT grant agreement was presented. Grant to provide reimbursement of cost to purchase and install updated crosswalk signs on Highway 24. Mayor noted that City Attorney had reviewed agreement and found no issues. Motion by Todd Reeves to approve agreement and authorize Mayor to sign was seconded by Vernon Sumner and carried.

Request for water bill adjustment at 560 Orange Street due to leak was presented. Motion by Dan Glotzbach to approve adjustment by half the overage was seconded by Trish Heim and carried.

Motion by Rick Towers to adjourn was seconded by Todd Reeves and carried. Meeting adjourned at 6:43pm.
