City Hall September 16, 2024

The Rossville City Council meeting was called to order on Monday, September 16, 2024 at 5:58 pm by Council President Trish Heim.

Council members present were Trish Heim, Vern Sumner, Todd Reeves, Dan Glotzbach, and Rick Towers.

Also present were Thomas Sipp and Myron Leinwetter.

Council reviewed proposed amendment to solid waste fund. Motion by Todd Reeves to amended solid waste budgeted expenses for calendar year 2024 from \$97,000 to \$102,000 was seconded by Rick Towers and carried.

Motion by Rick Towers to approve minutes of the September 3, 2024 meeting as presented was seconded by Todd Reeves and carried.

Motion by Dan Glotzbach to pay bills as presented totaling \$66,964.13 was seconded by Rick Towers and carried.

Motion by Todd Reeves to approve the agenda as presented was seconded by Vern Sumner and carried.

Police Chief Thomas Sipp reported that citation for nuisance violation was issued to owner of 321 Navarre, Motorola had responded in regards to car and body camera fees, the police department is contemplating Facebook post about unregistered vehicles located on properties in town, KDOT was contacted in regards to new crosswalks and light signals, that the new police vehicle to be picked up on Wednesday and upfitted next week, the police department received complaint about tree branches located at residential property that have now been cleaned up, and that the police department received new AED pads and now have operational pads in all three vehicles.

Alan Zlatnik arrived at 6:04 pm.

Chief Sipp also reviewed Police Data Report year to date as of August 31, 2024.

Utility Superintendent Alan Zlatnik reported that one of the city's generators had received servicing in Hiawatha. Superintendent Zlatnik stated that the one hundred gallon tank on the generator is not emptied very often and that the utility department plans on getting a portable tank.

Superintendent Zlatnik reported that the KDHE and EPA are being more lenient on the October 16th deadline for the lead and copper surveys but that he is still pursuing survey responses from the community.

Superintendent Zlatnik told council that he does not yet have a price for the playground mulch. Superintendent Zlatnik also told council he plans to spray for mosquitos again this week.

Myron Leinwetter reported that the Land and Water Conservation Fund grant application had been completed for the grandstands. Myron told council that he had been notified that the grant application had been successfully received and that the city can expect a response in October or November. Myron stated that the projected expenses listed on the grant application totaled \$100,000 and that the city would receive \$50,000 if the grant is approved. Myron also discussed establishing a tax exempt donation fund for the grandstands through the Rossville Community Foundation. Any donations made would be dedicated to the restoration and maintenance of the grandstands.

Motion by Dan Glotzbach to adjourn was seconded by Rick Towers and carried. Meeting adjourned at 6:22 pm.
