ORDINANCE 860

AN ORDINANCE RELATING TO RATES TO BE PAID BY CUSTOMERS TO THE CITY OF ROSSVILLE, KANSAS, FOR WATER, AMENDING SECTION #15-202 OF THE CODE OF THE CITY OF ROSSVILLE, KANSAS.

Be it ordained by the Governing Body of the City of Rossville, Kansas:

Effective September 5, 2024

Section 1. City Code section 15-202 is hereby amended to read as follows:

15-202 WATER RATES. Water shall be furnished by the city to customers at the following rates per calendar month:

- (a) Monthly Base Charge:
 - (1) Residential Rates: \$26.50;
 - (2) <u>Commercial Customers:</u> Prior to February 1st of each year, the city will determine the amount of water purchased by each commercial customer during the preceding calendar year. Based on such purchases, commercial customers will be charged during each of the ensuring 12 months a monthly base rate as follows:

Effective September 5, 2025

Section 1. City Code section 15-202 is hereby amended to read as follows:

15-202 WATER RATES. Water shall be furnished by the city to customers at the following rates per calendar month:

- (a) Monthly Base Charge:
 - (1) Residential Rates: \$27.00;
 - (2) Commercial Customers: Prior to February 1st of each year, the city will determine the amount of water purchased by each commercial customer during the preceding calendar year. Based on such purchases, commercial customers will be charged during each of the ensuring 12 months a monthly base rate as follows:

15-202 WATER RATES. Water shall be furnished by the city to customers at the following rates per calendar month:

(a) Monthly Base Charge:

(1) Residential Rates: \$27.00;

(2) <u>Commercial Customers:</u> Prior to February 1st of each year, the city will determine the amount of water purchased by each commercial customer during the preceding calendar year. Based on such purchases, commercial customers will be charged during each of the ensuring 12 months a monthly base rate as follows:
