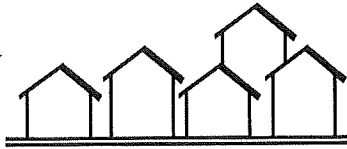

ORDINANCE 853

AN ORDINANCE DEALING WITH PENALTIES OF CHAPTER II AND REPEALING SECTION 2-112 AND 2-219 OF THE ROSSVILLE CITY CODE.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF ROSSVILLE, KANSAS:

SECTION 1. The following is hereby added to the City Code.

ARTICLE 5. PENALTIES

2-501 PENALTIES. Unless otherwise specifically provided herein, any person violating any section in this chapter other than 2-210; 2-216 and 2-301 shall be sentenced as follows:

- (a) Fine. A fine of not less than \$100.00 or more than \$499.00; or
- (b) Imprisonment. Imprisonment in the County jail for not more than 179 days; or
- (c) Both Fine and Imprisonment. A fine and imprisonment, both in accordance with subsections (a) and (b) of this section.
- (d) If any violation be continuing, each day's violation may be deemed a separate violation.
- (e) If any person be found guilty by a court of violating sections 2-201 and 2-205 his or her permit to own, keep, harbor, or have custody of animals may be revoked and no new permit issued.

2-502 PENALTIES FOR SECTION 2-210; 2-216 AND 2-301. Any person violating section 2-210; 2-216 and 2-301 of the chapter shall be sentenced as follows:

- (a) Fine. A fine of not less than \$499.00 and not more than \$1000.00; or
- (b) Imprisonment. Imprisonment in the County jail for not more than 179 days; or


- (c) Both Fine and Imprisonment. A fine and imprisonment, both in accordance with subsections (a) and (b) of this section.
- (d) If any violation involves multiple counts, each count may be deemed a separate violation.
- (e) Upon conviction of section 2-210 or 2-216, the judge of the municipal court may order the seizure and removal from within the city limits AND/OR the destruction of any animal that attacks a domesticated animal or a human which results in great bodily harm or death.
- (f) Upon conviction of section 2-301, the judge of the municipal court may order the seizure and removal from within the city limits, any prohibited animal.


SECTION 2. Section 2-112 and 2-219 of the existing Rossville City code is hereby repealed.

THIS ORDINANCE SHALL TAKE EFFECT AND BE IN FORCE FROM AND AFTER ITS ADOPTION AND PUBLICATION AS PROVIDED BY LAW.
